5. Working Group on Shunt Power Capacitors - Ignacio Ares

Standard was re-circulated in spring with 93% returned and 97% voting affirmative. The one negative vote could not be resolved and required documentation will be sent to IEEE.

Will complete next draft and send to IEEE for recirculation.
